In prior Sabal Trail Transmission, LLC ("Sabal Trail") communication to you, we indicated that we would keep you informed of important project related developments. On February 18, 2014, the Federal Energy Regulatory Commission ("FERC") issued a Notice of Intent ("NOI") to prepare an Environmental Impact Statement ("EIS") for the Planned Southeast Markets Pipeline Project (three related projects which includes the Sabal Trail Project). The NOI includes a Request for Comments on Environmental Issues, and a Notice of Public Scoping Meetings for Docket Nos. PF14-1-000, PF14-2-000 and PF14-6-000. Docket No. PF14-1-000 is specific to the Sabal Trail Project.

The NOI is issued as part of FERC's environmental review under the National Environmental Policy Act and announces the opening of the scoping process. A copy of the full NOI can be found on FERC's website, www.ferc.gov, and is also posted on Sabal Trail's website at www.sabaltrail.com/resources. Because your property referenced above is or has been part of an initial 600 foot wide study corridor or is within ½ mile of a proposed compressor station site, you should have recently received a letter from FERC regarding their NOI to Prepare an EIS.

As part of their environmental review of potential project related impacts, FERC will hold scoping meetings in order to gather input about the Project from the public and other interested stakeholders. For your information, enclosed is a list containing the date, time and location of these upcoming scoping meetings. These scoping meetings will enable FERC's environmental staff to identify relevant issues of major concern and define or refine the scope of the EIS. Information gathered during the scoping meetings will also help Sabal Trail prepare our environmental resource reports. In addition, Sabal Trail representatives will be available before and after the scoping meetings should you have questions or comments.

To be clear, these are FERC sponsored and controlled meetings. During these scoping meetings, FERC environmental staff will describe the environmental review process, provide relevant information about the Project, and answer any procedural questions. These scoping meetings provide stakeholders with an opportunity to make statements and directly address FERC's representatives regarding the Sabal Trail Project. Comments on the Project may also be submitted in writing, in addition to comments made verbally during the scoping meeting. These comments will become part of the formal record of FERC's

proceeding on the Project. Please also note that the NOI scoping period for comments lasts 60 days, closing on April 20, 2014.

Through Sabal Trail's ongoing extensive field work and route evaluation reviews, we have identified an initial "primary route" in your area that will be incorporated in Sabal Trail's draft Resource Reports planned to be filed this June which describe overall environmental impacts to the proposed primary route as well as various alternative routes that are evaluated along the proposed pipeline route. Attached please find a detailed county map which shows the location of the Primary route in your area. Additionally, Sabal Trail will have more detailed mapping available at the scoping meetings.


